


# 6. Function

The function is based on a single-acting vented pneumatic piston with spring return. As a result of its structure, the ZK1000 series product reduces interference contours, thereby enabling simple integration into the machine design. The ZK1000 series makes it possible to use different cutting geometries and materials.

The ZK1000 series has an integrated magnetic field sensor. This ensures process reliability for sensing the positions and transmitting them to the control system.

## 7. Installation

## 7.1 General installation information



### 7.2 Installing mechanic

The gripper can be installed on the mounting piece using the screw thread 2 and the locknut 10

- ► Secure the product using the locknut 10 . ⇒ Attach the locknut 10 so that it is hand-tight.
- ► Align the product.
- ► Tighten the locknut 10 to the specified tightening torque.



- ► Guide the cutting insert 12 into the housing 6. ► Secure the cutting insert 12 using the bearing pin 13.
- ► Secure the bearing pin 13 using the lock washers 11 .

# 7.4.2 Uninstallation

- ► Switch off the power supply to the product.
- ► Check the power supply for any residual energy. ► Remove the lock washers 11 .
- ▶ Pull out the bearing pin 13 . ⇒ In doing so, hold the cutting insert 12 securely.
- ► Take the cutting insert ① out of the housing ⑥.


